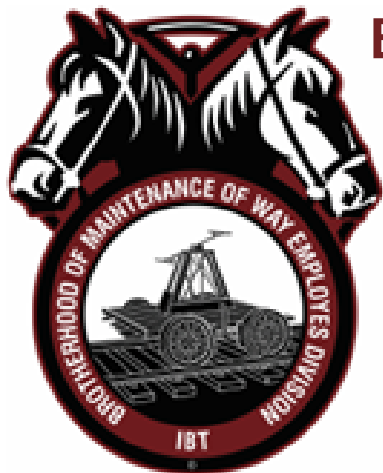

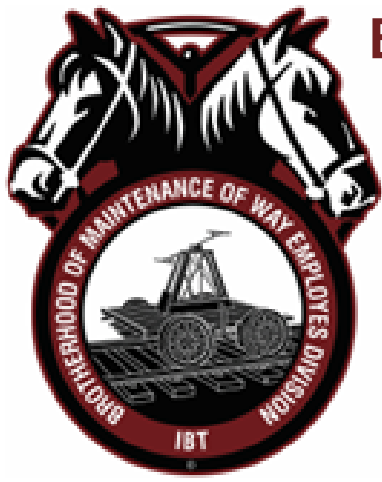

*If the retired member does not desire to convert the term life insurance into a full life insurance policy, the retiree is still entitled to a \$2,000 life insurance policy as a retired member covered under the NP. However, in order for the retiree to be entitled to the \$2,000 policy, they must apply for and be granted their railroad retirement annuity by the RRB within a 2-year period of the time from retirement. If the retiree dies and the annuity was never applied for, or was applied for and granted outside the 2-year period of time, then the \$2,000 benefit will not be payable upon death. There is nothing the retiree has to do other than to timely apply for and be granted their railroad retirement annuity by the RRB in order to receive their payment. Said in another way, the retiree does not have to file any specific paperwork with MetLife to acquire the \$2,000 life policy; this is handled in conjunction with the railroad retirement annuity application and approval process with the RRB.
