The meetings will begin Wednesday, Thursday, and Friday at 8:00am and lunch will be served on Wednesday, Thursday, and Friday. There will be a banquet dinner Thursday evening starting at 7:00pm. We plan to dismiss around noon on Friday.

When your lodge has decided how many members from the local will be attending, please contact Josh immediately as we need to plan accordingly for sleeping rooms, training materials, and meals. **If a reservation is made for you or someone in your local, and they decide NOT to attend, it is imperative that the reservation is cancelled at least thirty-six (36) hours in advance to avoid hotel no-show charges to the person whose name is on the reservation.**

Again, Josh must be notified before February 20, 2023, to ensure that we have enough sleeping rooms for all attendees and to ensure that we get the discounted rate. If your local does not notify Josh of the attendees, their names will not be put on the master rooming list and they may not have a room when they arrive or may be charged at a much higher rate than has been negotiated for our group.
